AGENDA ITEMS

Rocky Houston - Guest

Parking Passes – Kanipe Park is #10 in usage based on parking fees.

Due to high cost of sign under original plan, we will be obtaining a smaller sign, placing it closer to the fence and using t-posts to mount it. Hope to have it up prior to the Civil War Re-enactment and Living History Day.
